

Re-registration Process

IF YOU HAVE NOT RE-REGISTERED FOR 2007, PLEASE DO IT ASAP. YOU WILL NOT BE ABLE TO REFEREE IN 2007 UNLESS YOU DO SO. ALSO: REMEMBER TO ATTEND AT LEAST 6 HOURS OF IN-SERVICE-TRAINING (SEE POSTINGS ON THIS SITE). AND TAKE THE ON-LINE EXAM WHICH WILL BE POSTED WITHIN THE NEXT WEEK.

RE-REGISTRATION PROCESS This year we will be using a three-step process for referee registration. **Step 1. Registration forms** Each referee will receive his/her registration form direct from US Soccer. When you receive the blank form, please fill in the form completely, neatly and accurately. · Ensure you indicate if you are requesting an upgrade and if you are include an accurate count of your games (this is up to each individual referee to keep track of). · **SIGN AND DATE THE FORM** and check the appropriate box in Section 5. · Send the form with the appropriate registration fee for your grade or type of registration to: Dave Bruno, SRA25 College Road Stratham, NH 03885 When your form has been reviewed and accepted, you will be sent a 2007 referee patch appropriate to your current grade in the mail. **Step 2. IN SERVICE TRAINING SESSIONS** Attend at least 3, 2-hour In Service Training sessions. The purpose of these sessions is to keep you current with changes to the LOTG, changes in USSF interpretations of the laws, discuss game situations that have occurred which YOU feel you would like clarification on, and refresh your field mechanics. Other topics may be added at the discretion of the State Referee Committee. NHSA has divided the state into six regions. Every attempt will be made to have at least two of these sessions in each region. Overall the plan is to have a total of five different session topics. These will be offered in different areas on different days and times. The times and locations for these will be posted on the nhreferee.net website and updated when appropriate. Sessions will start in late August 2006 and run through early April 2007. Please be sure you SIGN IN on an attendance sheet for each session you attend. The State Director of Instruction will also attempt to schedule individual 5-hour sessions. These may be guided by state referee instructors or by a national instructor. In either case this will count towards the required in-service training for your referee grade. At the first In-Training Service Session you attend you will be given a new LOTG Book. Attending a session will be the only way you will be able to receive a LOTG Book. **Step 3. On-Line Examination** Each year we will post on the soccernh.org website a link to an on-line soccer examination. This year there will be 25 questions. You must take the examination to complete your re-registration requirements. Your objective is to achieve a grade of 80% or greater on the first attempt. The computer program will keep track of first right answers to determine your final grade. If you do not achieve a grade of 80%, and do not clearly understand the correct answers for those questions that were not answered correctly, you should contact the SDI, Bob Litman at: drbob20@comcast.net. State the questions, which were incorrectly answered, and the specific questions/concerns you have with the correct answers. The purposes of the on-line exam are to help your decision-making ability while working independently and use the LOTG appropriately. **ALL THREE steps must be completed to be successfully registered.**
